SECRET SERVICE REPORT

The source had a conversation with Feist, Andreas son of Johann regarding his argument with Reinhardt, Joseph son of Matthaus and - Reinhardt, Georg son of Matthaus who on the 15<sup>th</sup> of April drank heavily in the 6<sup>th</sup> barrack at Reinhardt, Joseph son of Matthaus' flat. There was not enough space for the guests making merry in the barrack №. 6, then to pass the evening they proceeded to 20<sup>th</sup> barrack to the flat of Barbara daughter of Anton Hupfner. Feist, Andreas son of Johann said that he had an argument in the 20<sup>th</sup> barrack court yard with Reinhardt, Joseph and Reinhardt, Georg and thought that they would come after him and, when going to bed he ordered others to not lock the hook on the door and he put an axe near his bed, which he intended to use, if Reinhardt, Joseph son of Matthaus and Reinhardt, Georg son of Matthaus came into his flat to again argue with him, if needed he would cut off their heads, but they did not come to his flat.

The source knows that following people attended this party i.e. the child's christening; – Feist, Regina daughter of Johann from barrack №. 24, Hupfner, Barbara daughter of Anton from barrack №. 20 (flat №. 6), Mehlem, Emma daughter of Anton from barrack №. 20 (flat №. 15), Teres, Maria daughter of Vickent of barrack №. 20 (flat №. 4), Joseph son of Matthaus Reinhardt's wife, Leon Bohlander with his wife /Jundt/ from the Lenin settlement and Joseph son of Matthaus, Reinhardt's mother Catharina daughter of Sebastian. The source talked about this christening party to Riefel, Elisabetha daughter of Jacob who said that Reinhardt, Catharina daughter of Sebastian and Feist, Regina daughter of Johann sang fascist songs such as:

"Deutschland, Deutschland, ober ales iber ales auf detsch selt" – /"Germany is above all in the world"/

<u>TASK:</u> Get in touch with Reinhardt, Joseph to start working him over, first elucidate his activity in the past, find close contacts, fellow-villagers knowing him well but not residing in the Berezovsk district.

<u>MEASURE:</u> Type secret service material in 10 copies and file to personal files of the evicted.

On 10 September 1954 it was announced to me, Jundt, Barbara daughter of Alexey/Alois, born in 1922, residing in the village of Kaltashy, Cheremissk village

soviet of Rezhech district, Sverdlovsk region, that according to the USSR Supreme Soviet Presidium's Edict of 13 July 1954 and the Council of Ministers' decree of 5 July 1954 my right is to only live within the Sverdlovsk region and can not without special preferences go to any place of the country while not on any official assignment.

In case that I am not on an official assignment of social utility or violate the routine set for those specially resettled or break public order at the places of settlement, I'll be deprived of the rights above.

## I oblige myself to:

- 1. When changing residence within the region, be struck off the register at the MVD special commandant's office and on arrival to a new place of residence immediately get registered at the new MVD organ.
- 2. Inform the MVD special commandant's office about going on official journeys outside the region.
- 3. Personally present myself at the MVD organ for registration once a year. It's also elucidated to me that for unauthorized taking my departure (escape) from the place of compulsory settlement, criminal proceedings will be instituted against me according to part 1 of article 82 of the RSFSR Criminal Code.
